**A transit permit application must be submitted to MAST at least 48 hours prior to departure.**  
**Applications are processed during office hours Mondays to Fridays.**

**You (applicant identified in part 1) are hereby granted permission to transit with the animal identified in part 2 between flights at Keflavik Airport, as detailed above, on the following conditions:**

1. You must advise the airline of your intentions. The ground service company will guide you and your animal from plane to plane.
2. You and the animal should be escorted directly from plane to plane without staying in the terminal building.
3. If this is not possible, and in the case of delays, you and your animal must wait in a designated area, as advised by the ground staff. If your animal needs to go to the toilet, there is a specific transit facility for pet animals in the airport, where she/he could be taken to. This facility could also be used as a waiting area for your animal in the event of delays.
4. Your dog/cat must be treated with a veterinary medicinal product licensed for the treatment of fleas and other external parasites no more than 120 hours and no less than 24 hours before the flight to Iceland. This treatment must be registered in your dog's/cat's vaccination booklet/passport and submitted to Customs or airport staff upon request.

**Under no circumstances is the animal permitted to enter the country.**
